Fire department

We need a PERSON to be fire chief. It would be possible to have a chief and assistant fire chief (seasonally). These people would need training, though. Training is essential. John Cousins and David Carter (Sedgwick fire chief) came by on Tuesday to take a look at the fire department and check out the fire site at Old Cove.

Efficient and effective government

Paul received some job descriptions from Donna Wiegler. There is one from Lamoine that has descriptions for every job in their town. There is also a description for the Cranberry Isles Administrative Assistant. Most of the Lamoine descriptions indicate that the positions are appointed by the selectmen.

Telemedicine

The Power Company and the Town may have come to a tentative agreement exchanging the Lampson property for the PoCo building at the dock.

Bob and Paul are concerned about the cleanup of the PoCo building. It will need to be handled properly by a company that deals with hazardous materials. Lobstermen's Association building is also available (as a backup). It could be moved or changed. The Bill's Island house might be available, too.

One of these tiny buildings could be used someday for the Historical Society. That would take a lot of work to make it a climate-controlled and appropriate location for historical documents.

Town land purchase process

There was some concern that the existing process could be discriminatory (because it has to be approved at town meeting).

Gerry will continue to pursue this. Committee should respond to Gerry's email with suggestions.

Survey

Meghan will put results on the website, at the store and the library, and write up a press release for Bill's newsletter.
