



Notice of Public Hearing on Proposed Floodplain Management Ordinance for the Town of Isle au Haut, ME

Public Notice: The Planning Board of Isle au Haut will hold a public hearing on a proposed Floodplain Management Ordinance on Thursday, July 7, 2016, at the Town Hall of Isle au Haut at 6 PM. Written comments will also be accepted until 30 days following the close of the public hearing. Address written comments to: Planning Board, Town of Isle au Haut, P.O. A copy of the proposed Ordinance is available in PDF format on the Planning Board section of the Town of Isle au Haut website (www.IsleauHautMaine.us; Boards and Committees→Planning Board), and for inspection at the Town offices, and at the Town library. Following the public hearing the Planning Board will consider whether changes are needed and can be made to the current draft. Once the public hearing process is concluded, the Planning Board will forward its final recommended version to the Selectmen for their consideration to place on the warrant for a Special or Annual Town Meeting. New coastal flood hazard maps delineating the 100-year flood zone become Effective for the first time at Isle au Haut on July 6, 2016. This Ordinance is required to be adopted by the Town in essentially its current form in order for the Town and its property owners to join the National Flood Insurance Program and be eligible to purchase subsidized flood insurance and be eligible for funds

planning for and recovering from natural disasters such as coastal floods.

Following the public hearing the Planning Board will consider whether changes are needed and can be made to the current draft. Once the public hearing process is concluded, the Planning Board will forward its final recommended version to the Selectmen for their consideration to place on the warrant for a Special or Annual Town Meeting. An agency of the Maine Public Utilities Commission, working cooperatively with the Knox County Emergency Management Agency administers the state-wide telephone system that receives and locates emergency calls by people dialing "911" on their phone. The State has adopted rules and a model ordinance that instructs a municipality as to how street names and numbers are to be assigned to dwellings and businesses. In addition to creating a detailed address map that conforms to the rules, the Town must adopt this ordinance essentially in its current form in order to qualify to become part of the 911 system.
