Project/section planning

Paul reviewed our plan to have each of the fourteen sections have a lead member from the committee and recruit sectional experts from the community.

Paul distributed the handout #1: "Proposed Approach for Each Section," and it was reviewed by the committee.

Karen Wilson has agreed to be involved with the natural resources section of the plan.

The list of sectional experts was revised to more evenly distribute the workload. See attached "List of Sectional Experts, revised 7-14-15."

It was determined that we are ready to launch the "engagement" portion of the process on our chapters. **Everyone** should start making initial contacts and recruit people for the committee.

Survey draft

It was proposed that the survey should include some context of what has been accomplished since 2011: grants received, actions taken.

For those sections without a chair/committee member yet, **Meghan** will appoint a person to close-read the section and identify critical issues.

The survey release target date should be August 1.

Bob is planning to present his proposed changes to the town zoning ordinance at the upcoming planning board meeting on July 30, at 5:30 PM. A public hearing on these changes will be held sometime in August.
