Meeting opened by **Paul** at 5:31 PM.

Review and approve minutes from 8/11/15 meeting

Bob moved to approve the 8/11/15 minutes with the following corrections:

- August 31 is a Monday, not a Tuesday
- Addition of **Kendra's** follow-up email message from after the 8/11 meeting **Kendra** seconded the motion and it was approved unanimously.

Survey status/issues

Meghan reported that she has collected 19 digital and 4 hard copy responses so far.

Committee members have received some comments from the public about how it would be easier to make informed answers to some survey questions if they knew how much the proposed projects would cost and what the town's current financial obligations are. There have also been some questions about what other possible forms of government or modifications in the current form there would be. It might be that there are not a lot of options that make sense for a town like IAH other than the listed options on the survey: executive secretary, administrative assistant, town manager, finance/budget committee.

Meghan will look at the Maine Municipal Association website to see if anything else looks promising.

It might be a good idea for us to send a link to the survey to various IAH organizations' email lists. Possible lists: ICDC (**Gerry** will check on this and get back to **Meghan**), Point

Lookout Association (**Rudi** will check on this and get back to **Meghan**), or Boat Company (**Meghan** will check with George Cole).

Proposed process to identify top implementation priorities

How to implement and what to implement? How to engage the community in the implementation process?

Paul has prepared Handout #1: "IAH Comprehensive Plan Worksheet." This is a spreadsheet that summarizes the policies and strategies identified in the 2012 plan, with **Paul**'s take on their current status, steps taken since 2011, any proposed action plans or next steps, and whether he considers each a candidate for his "Top 10" list of projects.

Paul has also prepared Handout #2: "Top 10 Candidates." This is a work-in-progress document. **Paul** suggests that coming up with a short list (a "top 10" or "top 5" list of priorities) would give us something to present to the community with the projects that we want to work on most strongly or first. Then we can start making concrete steps toward achieving these goals.

We should also (maybe as part of this list) try to look at quick hits/low-hanging fruit—projects that can be easily accomplished with a minimum of controversy.

Gerry suggested that we can probably reduce this list to a smaller number. Some of the proposed projects could be combined, as they are related. For example, discussions about the school or broadband could be linked with economic development, as they are important services for attracting new residents and families,

Paul noted that his current list does not cover the entire plan—he needs help from the rest of the committee to identify top projects in sections in which he has less experience.

To do: Everyone will take a look at their assigned sections (read through the spreadsheet) and note what needs to be added/changed.

Kendra will get the list that John made when he was making his map (about the houses and who lives in them) and give it to **Gerry** and **Bob**.

Rudi thinks that we might also be able to identify quick hits as we are reading through our sections.

Paul has another revision to the warrant article about the potential healthcare building: To see what sum of money the town will raise and appropriate for the purpose of creating and maintaining an island health care clinic in a location still to be determined. (Recommendation is \$5000).

We do not currently have a fire chief. What should we do about this? Ideas: increase compensation, create a job description (to include time commitment, responsibilities, accountability).

Gerry suggested we propose something for the warrant relating to the fire chief. **Rudi** pointed out that compensation is determined at the meeting, so if we want to raise the compensation, someone can propose that at the meeting. The warrant article is not necessary.

Nancy commented that the fire chief is an incredibly important job, especially on the island. Is increasing the salary going to help the problem? **Harold** suggested that for any of our articles going on the warrant, it is very important to talk to voters before the meeting to gauge support and make sure everyone understands the issue.

Rudi asked whether the town is willing to spend money on fire equipment. The plow trucks are also in questionable condition—have they been repaired over the summer to prepare for the coming winter?

Harold thinks that the responsibilities of fire chief need to be specifically delineated at the town meeting. Then people might better know what they're signing up to do.

What can we contribute? We could draft job descriptions. (Samples might be available on the ME Municipal Association website.) If the selectmen think this is something important, maybe we could be the ones to draft the documents.

Paul: We do have the authority to take initiative on some of these projects ourselves. A lot of the things we are discussing were approved by the town in the last comprehensive plan. Projects such as improving the fire department could be something we do as an Implementation Committee. There is money in the budget for fire chief training. The fire chief answers to the selectmen.

It is suggested that representatives from the committee should meet with the current selectmen about the fire department to see what actions we should take. **Paul** and **Bob** will attend the next selectboard meeting. We should establish a relationship with the selectmen. The fire department is likely a good opening issue.

Update on specific implementation priorities

There currently appear to be three or four alternatives for housing a future medical center/clinic:

- Parsonage: The church appears interested in leasing the building, but there is some conflict over whether the full building would be available, or just a couple of rooms. Being able to stay at the parsonage is a draw for summer ministers.
- Power Company building at the town landing: This is owned by the town and leased to the Power Company. The Power Company is currently very busy with new developments in addition to regular maintenance, and does not have time to work on clearing it out. There is no septic, but there is a well.
- ICDC house for sale: ICDC will be meeting soon. The first priority is--and will remain--to sell to a year-round family. The advertisement will be edited to reflect its potential use for a community building.
- Other homes: Payson's house, for example? (Listed for \$400,000)

The town also has housing needs for the Historical Society, library collections, a fitness center, etc.

Bob talked to Laura Jacobis (who donated AED to the town). She is interested in helping out, especially in the medical area, though she likely does not have time to chair any efforts.

Gerry talked to Rachael Dugan about medical projects: she is interested in being involved. She has done telemedicine at her job and is a medical professional.

Kris says we should also loop in Sharon Daley from the *Sunbeam*. **Nancy** enthusiastically agrees. Other people to talk to: Donna Wiegle of Swan's? Scott Schiff-Slater? Scott Planting?

Sharon Daley will have an informational meeting at some point about what the Seacoast Mission can do to help.

A medical center would be a draw for new families.

Set date for next meeting

The next selectboard meeting is scheduled for **Monday, September 7, at 6:30 PM**. Our next meeting will be **Friday, September 18, at 5:30 PM**.

Meeting adjourned unanimously at 7:06 PM.

> Town of Isle au Haut shall not publicize the locations of rare plant and animal communities The town of Isle au Haut shall cooperate with State and Federal agencies, National Park Service and other organizations to monitor critical natural resources The planning board shall ensure that shoreland zoning ordinances meet the state minimum standards, enforce resource protection and shoreland zoning ordinances and ensure that any new development will not harm Isle au Haut's critical natural resources The planning board shall investigate modifying zoning ordinances to require subdivision or non-residential property developers to look for and identity any critical natural resources that may be affected and take necessary measures to protect those resources The town of Isle au Haut shall adopt natural resource protection practices and standards for construction and maintenance of public roads and properties and require their implementation by the community's officials, employees, and contractors The town shall continue efforts to protect the natural environment of the town including encouraging recycling, energy efficiency, best management practices and green building

Marine Resources

It shall be the policy of the town of Isle au Haut to support and encourage all appropriate marine based enterprises, including fishing and aquaculture
It shall be the policy of the town of Isle au Haut to maintain and improve the water quality of the surrounding waters
It shall be the policy of the town of Isle au Haut to provide safe and efficient public access to marine waters and actively preserve current working waterfront properties

The town, through the planning board, selectmen and interested parties, shall develop a shoreline access plan to maintain public access to the shoreline. The town, through selectmen and interested parties, shall work with other organizations to ensure that the interests of Isle au Haut fishermen are represented. The town, through selectmen or designate shall investigate the development and implementation of a shellfish/worm ordinance. The planning board and code enforcement officer shall enforce all shoreland zoning ordinances and other ordinances designed to protect marine water quality

Land Use

It shall be the policy of the town of Isle au Haut to direct the planning board to reexamine current zoning ordinances and recommend changes appropriate to the current situation and responsive to the concerns of island residents and landowners

It shall be the policy of the town of Isle au Haut to maintain and adopt land use strategies that will maintain the unique character of the Island while encouraging a sustainable year round community

It shall be the policy of the Town of Isle au Haut to coordinate the community's land use strategies with other local and regional land use planning efforts by working with surrounding communities

It shall be the policy of the Town of Isle au Haut to encourage affordable housing while protecting the natural character of the island it shall be the policy of the town of Isle au Haut to support the level of financial commitment necessary to provide needed infrastructure in growth areas

It shall be the policy of the town of Isle au Haut to maintain efficient, consistent and transparent permitting procedures, especially in growth areas.

It shall be the Policy of the Town of Isle au Haut to protect critical resource areas from the impacts of development

The Planning Board shall consider implementing a height restriction ordinance Small scale home based business and occupations shall continue to be permitted, in accordance with current zoning

Heavy industry shall continue to be restricted on Isle au Haut, in accordance with current zoning Marine based land uses shall be supported, in accordance with current zoning

The Town of Isle au Haut shall designate the accessible interior, areas near traditional settlements, Coombs Mountain and the overlay affordable housing zone as growth areas

At least 75 percent of new growth-related capital investment shall be made in the designated growth area

The Planning Board shall investigate and draft an ordinance permitting accessory apartments or duplexes in appropriate areas.

The Planning Board shall update the minimum lot size in the accessible shoreland to be consistent with State shoreland zoning minimums. It is recommended it should increase from one-quarter of an acre to one acre

The Planning Board and Town of Isle au Haut create an affordable housing overlay zone including appropriate town and ICDC owned lands with a minimum lot size of one acre to promote affordable housing

The Planning Board shall maintain fair and efficient permitting procedures and appropriate fees, and streamline permitting procedures in growth areas The chair of the Planning Board and First Selectmen shall periodically meet with neighboring communities and consult with The Hancock Planning Commission and the Maine State Planning Office to coordinate land use designations and regulatory and non-regulatory strategies

Isle au Haut's Planning Board shall provide the code enforcement officer with the tools, training, and support necessary to enforce land use regulations, and ensure that the Code Enforcement Officer is certified in accordance with 30-A MRSA §4451 Isle au Haut's Planning Board shall track new development in the community by type and location Isle au Haut's Planning Board shall evaluate this plan every five years

Fiscal Capacity

It shall be the policy of the town of Isle au Haut to encourage long range fiscal planning to avoid or minimize excessive increases to property taxes while maintaining quality public services
