2012-2013 Budget

Bob reviewed budget draft #2 which is \$1,483 less than draft #1. The proposed school budget will require \$20,612 (12%) less tax revenue than the current budget thanks to the a 12012-13 ower budget and a larger carryover balance from the 2010-11 fiscal year. Motion by Suc, second by Louise, to adopt draft #2 of the budget as amended in the amount of \$190,013 Vote: 4 yes; 0 no.

School Calendar

Bob did not bring a draft calendar. He will have one for the next meeting.

7. Updates on Chimney or Electrician

Sue called both the mason and the electrician. Neither has called her back. We'll have to wait until spring to follow up on these building maintenance issues. Kirsten will call a local person to inspect the flashing on the chimney for leaks.
